- 8. **CPA HELP-**Clerk Sandy Beaudet requested to get a CPA to go through the GL to clean up the errors found in cash receipting cancelling items out. Waiting on local quotes and referral from auditors. Cost so far BS&A \$150.00 and hour plus extras, Private CPA in Bay City \$125.00 hr. plus mileage and lunch. 3 to 4 days estimated so far. Will come back to board once I have more details.
- 9. **Cemetery-**We are working on getting quotes for limestone etc. to define the roads with circle drives. Moving the west gate over approximately 15 feet to keep drivers

from driving over an area of lost graves. All together close off the front entrances and make one side entrance for all to protect the plots right at the driveway line at first entrance. Flags for our veteran's will be going out for Memorial weekend. Clean up will continue in the cemetery.

## Reports:

1. Fire Department-report was read by Fire Chief Doug Bourgeois.

In April 2023, the Beaver Creek Fire Department was busy attending to the following:

- BCFD responded to 23 Requests for aid, with 1 request for mutual aid assistance to Grayling.
- BCFD responded to 3 straight calls to Weyerhaeuser in April.
- April training was Wildland Fire training.
- We had one confined space standby at Weyerhaeuser.
- Two firefighters have completed their EMT class and are waiting to take the national registry exam. Two Firefighters are currently in Ride-Along at Frederic for the EMT class.
- E-1 was in for repair of both rear springs.
- Received payment from Arauco for training and confined space.
- The regional AFG grant for 101 SCBA backs with 10 being for BCFD is still in the running. Our cost if awarded would be approximately \$7,800 for ten packs.
- We had one officer pass Fire Instructor one class.
- The Grass Rig G-751 is in service for the wildland fires.
  - 2. Supervisor-
  - 3. DPW-Supervisor and Trustee Lee Riley attended MTA Conference in Traverse Bay in April.
  - 4. Zoning-Planning Commission changing height requirements from 25' to 35'. Changing short term rentals to permitted. Marijuana added to the list under commercial on map marked pink and red.
  - 5. Board Comment-Clerk Sandy Beaudet was invited to Lansing, MI. to be a guest at the Board of Elections. My deputy and I took our ballots to run through election sources high speed machine to see if the outcome was the same as our voting machine the day of election due to the two breakdowns, I had election day. BOE report is still being established and I will bring to the board once I acquire the report.

Public Comment: Several residents came to the meeting voicing concerns with the Beaver Creek Cemetery.
