The board held second interviews with Doug Bourgeois and with Glenn Mohney.

Motion by Van Nuck and seconded by Meisner to hire Doug Bourgeois as our fire chief. Roll call vote: Ayes: Meisner, Van Nuck. Nays: Raybuck, Little, Hartman. Motion failed.

Motion by Hartman and seconded by Raybuck to hire Glenn Mohney as our fire chief. Roll call vote: Ayes: Raybuck, Hartman. Nays: Van Nuck, Meisner, Little. Motion failed.

Motion by Van Nuck and seconded by Little to pay the new fire chief \$50,000 per year, reevaluate in six months at budget time with one year salary/performance probation. Roll call vote: Aye: Van Nuck, Meisner. Nays: Little, Raybuck, Hartman. Motion failed.

Motion by Raybuck and seconded by Little to pay the new fire chief \$52,000 per year, reevaluate in six months at budget time with one year salary/performance probation. Roll call vote: Ayes: Little, Raybuck, Hartman. Nays: Meisner, Van Nuck. Motion passed.

Motion by Little and seconded by Meisner to change the fire department captain wages to \$15.00 per hour, effective January 1, 2017. Roll call vote with all ayes, motion carried.

Motion by Little and seconded by Raybuck to adjourn the meeting at 6:10 pm. All ayes, motion carried.

#### APPROVAL OF THE MINUTES:

Motion by Little and seconded by Van Nuck to approve the minutes from the December 13, 2016 meeting. All ayes, motion carried.

Motion by Little and seconded by Raybuck to approve the minutes from the December 19, 2016 meeting. All ayes, motion carried.

Motion by Little and seconded by Raybuck to approve the minutes from the December 22, 2016 meeting with two corrections, in first sentence 10:00 pm should say 10:00 am and in paragraph number 6, the 4:00 should read 4:00 pm. All ayes, motion carried.

Motion by Little and seconded by Van Nuck to approve the minutes from the December 27, 2016 meeting. All ayes, motion carried.

Motion by Little and seconded by Raybuck to approve the minutes from the January 3, 2017 meeting. All ayes, motion carried.

### SUPERVISOR REPORT:

We had 11 applications for the fire chief position and worked very hard to hire the right person. It has been a very busy month.

### **HLUA:**

Waiting for Lyon Township to decide what they are going to do with state proposal.

#### FIRE DEPARTMENT:

It has been a slow month with only 8 calls, mainly snowmobile accidents and rollovers. They are doing inside training. Ken Ruby is on a Leave of Absence as he has retired and away for several months this winter. Robbin Meyer has been promoted to Captain and Bill Morrow and Bill Miller have been promoted to Lieutenants.

Roger said thank you to the township, he loves the township and will be glad to help in any way he can.

#### DPW:

The transfer site has had issues with the compactor freezing and had trash piled up on the ground. They will try turning the heater on earlier.

#### PLANNING/ZONING:

The zoning administrator has been dealing with one complaint and had the hard drive on his computer replaced.

# GRAYLING CHARTER TOWNSHIP/BEAVER CREEK TOWNSHIP UTILITIES AUTHORITY:

Attorney has been working on several issues: agreement with state, getting boundaries set, warranty deeds etc. Everything is moving along.

#### OLD BUSINESS:

- 1. Move "Transfer Site Over Hang" to next agenda when supervisor has had time to get estimates.
- 2. Attorney Meihn asked for a date to have a working dinner with township personnel, which should be set to fall in the next two months on a Thursday, Friday or Saturday night. Attorney Meihn needs to discuss with us several changes in the law and the board's liability.
- 3. The furnace repairs are being worked on.
- 4. Several questions came up on the proposed zoning changes from the planning commission and a copy needs to go to the attorney before we approve the changes. Put on next month's agenda. The supervisor will send the language to the attorney.

## NEW BUSINESS:

- 1. Motion by Little and seconded by Raybuck to accept the Beaver Creek Township Amended Poverty Guidelines Resolution, for the year 2017, as presented. Roll call vote with all ayes, motion carried.
- 2. Add "medical marijuana" to the February Agenda and we will see what the court decides. We need to add signs/notices in public places stating that you cannot smoke medical marijuana on township property, add in hall rental agreement, post at the fire hall, on web site, in pavilion and at the transfer site.
- 3. Motion by Little and seconded by Meisner to sign the zoning administrator's contract for the 2016-2017 fiscal year. Roll call vote with all ayes, motion carried.
- 4. Motion by Van Nuck and seconded by Little to have the township stay open until 5:00 pm on Wednesdays with a board member being here until 5:00 pm with the secretary, and having the secretary start at a later time on Wednesdays. All ayes, motion carried. The supervisor stated that she had talked to the secretary and that she was good with the hours change. The attorney stated that we need a "Safety Plan" in place and possibly having the fire department do a security sweep at 5:00 pm. This will start immediately.
- 5. Discussion regarding upcoming MTA classes and how much money is available for education classes. Motion by Van Nuck and seconded by Meisner to have the supervisor, zoning administrator and planning commission members attend a planning/zoning class on March 8<sup>th</sup> in Frankenmuth. All nays, motion failed. Motion by Van Nuck and seconded by Raybuck to have the supervisor and zoning administrator attend a planning/zoning class on March 8<sup>th</sup> in Frankenmuth. All ayes, motion carried.

- 6. There was a GIS mapping meeting held at the road commission regarding updating of mapping in the county. There will be a three year proposal, but we are not sure of the cost. More information is coming.
- 7. Motion by Little and seconded by Van Nuck to accept the Employment Agreement between Beaver Creek Township and Doug Bourgeois, new fire chief, as prepared by our attorney. Roll call vote with all ayes, motion carried.
- 8. Motion by Hartman and seconded by Little to accept the Retainer Agreement from Attorney Greg Meihn, November 2016 thru October 31, 2017, with two corrections: correcting to date at the top of page 1 to read "November 2016" and at the end of the first paragraph removing the 15 from the 2017. Roll call vote with all ayes, motion carried.
- 9. Motion by Little and seconded by Van Nuck to accept the quote from I.T.Right for \$320.00 to replace two hard drives in the supervisors and deputy clerks computers. Roll call vote with all ayes, motion carried.
- 10. Motion by Little and seconded by Van Nuck to pay Accounts Payable in the amount of \$27,038.45, checks #31117 thru #31155. Roll call vote with all ayes, motion carried.

Motion by Van Nuck and seconded by Hartman to adjourn the meeting at 11:20 am.
