Agenda:

The agenda for today's special meeting is to make decisions on Fire Trucks for Beaver Creek Fire Department. Clerk Sandy Beaudet motioned to approve the agenda with support from Treasurer Witnee Rose. All Ayes, motion carried.

1. Fire Truck-Supervisor Dan Bonamie reiterated from last meeting on the cost and condition to repair our rig,80,000 engine 1 and 40,000 in repairs for Engine 3, Our only engine in service Engine 2, now broke down cost is around 6000 to have repairs with labor. Chief Nelson and Captain found a truck in Texas, Supervisor Dan Bonamie and CSI mechanic

took a trip to Dallas, TX to look over a used truck for the fire department. Price came down from 80,000 to 65,000 Supervisor Dan Bonamie asked what can you do and the price was reduced to 63,000. Great looking truck with no rust!

The cost to have the truck brought to us is \$5500 towing, needs minimal lightening updates, has new tires but not for our terrain. Comes with 25k in tools. Jaws etc. 5-10k for upgrades we are up to 83,500.

Clerk Sandy Beaudet motioned to loan the money out of our general with a 3 percent interest rate back to the township. 6-year term. Interest first year 2028.65- and first-year payment 12,895.42 63,000 for the truck, 5500 to transfer the truck to Beaver Creek. 5000 in new tires and 5-10k in upgrades needed worse case scenario. Totaling 83,500. And asking to take 6000 out of Fire departments budget to repair Engine 2. Supported by Trustee Doug Yanniello.
