Reports:

1. Fire Department- Fire report was given by Chief Doug Bourgeois.

Below is the board report for the December 2022 Township Board Meeting with the November 2022 statistical fire report. Please feel free to call me if you have any questions.

In November 2022, the Beaver Creek Fire Department was busy attending to the following:

- BCFD responded to 26 Requests for aid, with one request for mutual aid assistance.

- I have sent an invoice to MABAS for the 2 firefighters and Engine 720 for the 6-day deployment. I received notice that the invoice looked good and was being forwarded to the appropriate department for reimbursement.
 - November training was a Joint training with Grayling Fire Dept. on their new platform truck, a pre-incident plan walkthrough with Weyerhaeuser, and Firefighter Right to Know (MIOSHA required)
 - We had no confined space standby in November.
 - BCFD was contracted to train Arauco staff on fire extinguisher training, Fire Hydrant, and Hose line operations. This training is 20 hours in total.
 - Four Firefighters have been enrolled in EMT classes, two at Frederic and two at Denton.
 - Chief Bourgeois attended Crawford County Emergency Managers Meeting and MABAS Meeting in November.
2. Supervisor Dan Bonamie and Clerk Sandy Beaudet on MTA meeting discussing the Grayling Expansion and the PFAS contamination in the area spreading.
 3. Clerk Sandy Beaudet did and hand count on November 8, 2022 election and need to take next steps in findings to discuss any further.

Public Comment:

Mr. Terry Stocker and family attended to voice interment of his brothers' remains to take place even though policy is set in place that this will not proceed until next spring. Snow on ground prior to closing and as of December 1, 2022 cemetery is closed until spring.
